It may be noted that the Board has not authorized or recognized any person / vendors / firms / agencies / companies to carry out the activities related to installation of ETP / STP. Further it may also be noted PCBA will not accept any liability for any loss or damage that may suffered or incurred directly or indirectly through correspondence with such individuals or agencies.

If someone across such fraudulent incident or have any information regarding solicitation of such practices please assist PCBA in taking appropriate action to curb such malafide activities.
