ATTENTION: All Health Care Facilities including Hospitals, Nursing Homes, Clinics, Dispensaries, Veterinary Institutions, Pathological Laboratories, Blood Banks and all such institutions generating Bio-Medical Waste.

In accordance to the Bio-Medical Waste Management Rules, 2016, it is to hereby direct all the Health Care Facilities including Hospitals, Nursing Homes, Clinics, Dispensaries, Veterinary Institutions, Pathological Laboratories, Blood banks and all such institutions generating Bio-Medical Waste to apply for grant of authorization immediately which have not yet obtained authorization for handing the Bio-Medical Waste generated by them.

Further all occupiers of Health Care Facilities are hereby directed to take all necessary steps to ensure that Bio-Medical Waste is handled without any adverse effect to human health and the environment.

Further strict legal action under the purview of the environmental laws in force shall be initiated against Health Care Facilities which are found to be operating without obtaining authorization leading non compliance to the Bio-Medical Waste Management Rules, 2016.
