NOTIFICATION

Dated Guwahati, the 12th January, 2024

No. PCBA/G-45/23-24/63 ²⁴⁰³ : Consequent upon the approval of the Pollution Control Board, Assam in its 105th meeting in Agenda No. 105.4, two Regional Offices under the Pollution Control Board, Assam are hereby created in the name and Head Quarter as below:

- i) 'Regional Office-Tinsukia' with Head Quarter at Tinsukia.**
- ii) 'Regional Office-South Bank' with Head Quarter at Chaygaon.**

These offices will be operational from the date of taking over Charge by the Regional Officers posted against the said Regional Offices.

No. PCBA/G-45/23-24/63-A, : Consequent upon creation of two Regional Offices in the name of Tinsukia Regional Office, Tinsukia and South Bank Regional Office, Chaygaon the boundaries of the RLO-Bongaigaon, RO-Kamrup, RLO-Tezpur and RO-Dibrugarh are rationalised and boundaries of the Regional Office-Tinsukia and South Bank Regional Office, Chaygaon are fixed as below for performing assigned responsibilities of Pollution Control Board, Assam.

RLO-Bongaigaon : From the areas within its present boundary of RLO-Bongaigaon, the areas of entire Goalpara District and South Salmara-Mankachar districts are subtracted from the Bongaigaon-RLO.

RO-Kamrup : From the areas within its present boundary of Kamrup Regional Office, the entire areas of Palasbari, Chaygaon and Boko Revenue Circle are subtracted from the Regional Office-Kamrup.

RLO-Tezpur : From the areas within its present boundary of RLO-Tezpur, the areas of entire Lakhimpur District are subtracted from the RLO-Tezpur.

RO-Dibrugarh : From the areas within its present boundary of Dibrugarh Regional Office, the areas of Tinsukia are subtracted from the Dibrugarh Regional Office and the entire areas of Lakhimpur District are added to the areas of Dibrugarh Regional Office.

Regional Office-South : The entire areas of Goalpara and South Salmara-Mankachar District
Bank, Chaygaon and the entire areas of Palasbari, Chaygaon and Boko Revenue
Circle of Kamrup Rural District.

The respective Regional Officers will hand over and take over the areas as rationalised above, along with the relevant documents pertaining to the industries etc. under their jurisdiction, at the earliest, for smooth functioning of the activities of the Board.
