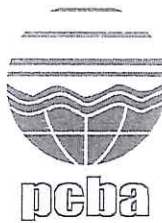

**SUB.: CATEGORIZATION OF INDUSTRIES**

In pursuance to the categorization of industries formulated by Central Pollution Control Board and as recommended by the working group, constituted by the Central Pollution Control Board for the said purpose, Pollution Control Board, Assam constituted a committee to categorize the industrial sector which doesn't fall under any of the four categories i.e. Red, Orange, Green & White. The committee has categorized the following industrial sector, based on the pollution index as under:

Sl. No.	Industrial Sector	Category	Remarks
1	STP (Minimum 30 households)	Green	Mainly water polluting
2	Coal storage depot	Green	Acidic water discharge & fugitive emission
3	Tea Industries (Coal used as fuel)	Orange	Mainly air polluting
4	Resorts/Banquet Hall / Lodge	Green	Mainly water polluting
5	Railway Coach maintenance & washing depot	Orange	Waste water generation and HW generation
6	Entertainment park (Water park etc.)	Green	Waste water generation
7	Automobile fuel dispensing station	Orange	VOC & HW Generation
8	Concrete batching plant	Green	Fugitive dust emission
9	Wet mix macadam plant	Green	Fugitive dust emission
10	Engineering workshop with heat treatment metal finishing operation, painting etc.	Orange	Both air emission and HW generation
11	Car washing centre	Green	Waste water generation with TSS, Oil & Grease

The order will come into force with immediate effect. However stake holders can raise objection to the undersigned within 15 (fifteen) days from the date of notification.
