Department and Autonomous Body. (Work order and Completion certificate should be submitted at the time of issue of tender.)

Application requesting for the issue of tender paper must be accompanied by supporting documents for the qualifying criteria as stated above along with a D.D./Bankers Cheque of Rs. 500.00 (Rupees five hundred) only as cost of tender paper (non refundable) in favour of the Member Secretary, Pollution Control Board, Assam.


In case of downloaded document the above mentioned documents and amount should be submitted alongwith the tender in a separate envelope supersiding as "Qualifying documents and cost of tender paper".

## ANNEXURE-A

### Other Terms & Conditions:

1. Rates shall be quoted in the Bill of Quantity (BOQ) furnished in **Annexure-B** in figure and words. If there are variations between the rate of figure and words, the rate quoted in words shall be considered.
2. All pages of the tender document shall be signed and dated at the lower right hand corner by the tenderer or by a person holding power of attorney authorizing him to sign on behalf of the tenderer before submission of the tender.
3. The work shall be completed within 30 (thirty) days from the date of issue of the formal Work Order.
4. The rates shall be inclusive of GST and all taxes, forest royalty, cess, octroy, loading & unloading and transportation etc. of all the materials to site.
5. The contractor shall arrange all the plants, equipments, machineries etc. required for the work to site for which no extra charges will be paid.
6. Any abnormal rate quoted in the tender will summarily be rejected for which no communication will be made.
7. The Earnest Money shall be paid in the form of Demand Draft/ Banker's cheque drawn in favour of the **Member Secretary, Pollution Control Board, Assam** payable at Guwahati.
8. Defect liability period : 6 (six) months from the date of completion.
9. 10% of the Bill Value will be retained as Security Deposit and will be released after 6 months from the date of completion of work. Any damage or defect in the work during this period due to materials supplied by the contractor or bad workmanship shall have to be rectified or replaced by the contractor at his own cost or the Engineer –in-charge may cause the same to be made good by other workman and deduct the expenses from the security deposit. No interest will be paid on security deposit.
10. Documents to be enclosed:
  - a) Contractor registration certificate copy.
  - b) Experience certificate alongwith work order copy.
  - c) GST Registration certificate.
  - d) PAN card copy.
11. Any tender submitted without the documents mentioned above will be considered as incomplete and the tender will be rejected for which no communication will be made.
12. The contractor will arrange for water and electricity of his own. However, the Board may provide electricity on the request of the contractor and under the terms and condition fixed by the Board.
