6. The courts at Guwahati shall have exclusive jurisdiction to entertain and try all matters arising out of this contract.
7. Party should have PAN card, Trade license, GSTN registration.
8. The amount should be mentioned in the price bid format. Party may quote rate in item wise or as lump sum amount in each category.
9. The materials offered for disposal is on "As IN WHERE IS BASIS" in top floor and ground floor of Pollution Control Board, Head office, Bamunimaidam, Guwahati-21.
