The hoardings are proposed to be placed in Guwahati, Nalbari, Nagaon, Sivasagar and Silchar town/city. For details terms and condition the interested party may visit Boards website www.pcbassam.org.

The Eoi will be received upto 12.00 noon of 28th December, 2021 and will be opened on the same date at 2.00 PM in presence of the bidders or their representatives who would like to be present.

Specification and terms and condition for printing and installation of Hoarding.

1. Sealed Expression of Interest (Eoi) are invited from the registered advertising firms/agencies having minimum experience of 3 years for installation of Hoarding.
2. **Hoarding Specification:**

3. Firm/Agencies shall submit total cost of installation of the Hoarding including-printing, designing, permission from concerned authority, transportation cost, erection, mounting and taking care during entire contract period etc.
4. Tender shall be submitted separately for each Town/City in a closed envelop super scribed as “Eoi for Printing and Installation of Hoarding in the Town/City of.....”

5. 10(ten) prominent locations shall be proposed in EOI against each town/city for placing of hoarding.
6. A Demand Draft amounting Rs 500.00 (Rupees five hundred) only (non-refundable) drawn in favour of 'Member Secretary' Pollution Control Board, Assam should be affixed with the quotation.
7. Turn over certificate of last two years along with up to date tax clearance certificate and valid registration certificate shall be submitted along with the quotation.
8. Basic Rate quoted should be exclusive of GST. However, GST shall be shown separately in the quotation.
9. The undersigned reserved the right to accept or reject any or all quotations received hereunder without assigning any reason thereof.
10. All documents submitted should be duly signed by the authorised signatory of the firm
11. Any dispute arising in this matter shall be under jurisdiction of courts in Guwahati city (Assam).
