As per approval of Govt. of Assam, Environment & Forests Department vide their letter No. FRM.149/2018/235 dtd. 23.06.2020, Pollution Control Board, Assam intends to select the private sector developer for the design, construction, operation, and maintenance of the HWTSDF through a competitive bidding process. Now, Therefore the Govt. of Assam Invites 'Expression of Interest' from reputed Indian companies / Joint Ventures (JV)/Consortium for setting up and operating the Common Hazardous Waste Treatment, Storage and Disposal Facility (TSDF) in Assam on Build, Own, Operate and Transfer (BOOT) mode for a period of 30 years. Having the experience, capability, expertise and technology matching international standards for the:

- Design, Finance and Construction of a HWTSDF in the State of ASSAM.
- Operations and Maintenance of the HWTSDF in the State of ASSAM.

The Successful Bidder is expected to be responsible for the design, **finance**, construction, all operations, and maintenance of the HWTSDF as mentioned below:

- Establishment of the HWTSDF after obtaining all necessary approvals and in compliance with the guidelines of Central Pollution control Board.
- Receiving and Transportation of hazardous waste from Generator's facility to the HWTSDF
- Inspection of hazardous waste
- Carrying out Treatment, Storage and Disposal of hazardous waste residues
- Collection of Charges from Generator
- Transportation of residue/rejects such as ash/slag generated, to HWTSDF for disposal
- Monitoring on-site including emergency preparedness
- Reporting to regulatory authorities as needed
- Carrying out Public information and consultation

The intending participants must submit their Expression of Interest along with the following documents/information:

- i) Detailed Financial capability statement supported with Audit reports for last 5 (five) years.
- ii) Technical qualification supported with list of similar projects completed during the last 5 (five) years.

- iii) List of ongoing projects.
- iv) Details of Manpower along with qualification profiles of key personnel,
- v) List of machineries, equipment owned by the company.
- vi) Any other relevant documents/information along with detailed techno business proposal for the prequalification as well as selection.

Schedule of land and location:

The Govt. of Assam has allotted 30 bighas of land at Geleki in Sivasagar district for the said purpose (details at Annexure).

Key Timelines:

The Expression of Interest must be submitted in a sealed envelope superscripted "Expression of Interest for setting up and operating the Common Hazardous Waste Treatment, Storage and Disposal Facility (TSDF) in Assam" to the "Member Secretary, Pollution Control Board, Assam" on or before **2.00 p.m. of 07/08/2020**. The Pollution Control Board, Assam will not accept any EOI beyond 2.00 p.m. of 24/08/2020.

Earnest Money Deposit (EMD):

The Expression of interest should be accompanied with a demand draft of Rs. 5.0 lakhs in favour of the "Member Secretary, Pollution Control Board, Assam" payable at Guwahati as EMD, which will be refunded to the unsuccessful Participant and same shall be converted to security deposit in case of the successful bidder.
