The Pollution Control Board, Assam (PCBA) invites Expression of Interest (EOI) from prospective bidders for setting up and operating an Integrated Waste Management Facility comprising of a Common Hazardous Waste Treatment, Storage & Disposal Facility and a Common Bio-medical Waste Management Facility for the State of Assam on Design, Finance, Build, Own, Operate and Transfer (DFBOOT) for a period of 25 years.

The preference would be given only to those prospective bidders who have rich experiences of setting up, operating such integrated facilities of common Hazardous and Bio-Medical Waste as per the provisions of HOWM Rules, 2016, BMW Rules, 2016 and Guidelines of Central Pollution Control Board. (CPCB).

Adequate land required for the Integrated Waste Management Facility shall be provided by the Government of Assam within the Solid Waste Disposal Facility site at Lekai, Dibrugarh.

The details of the EOI are available for downloading from the website of Pollution Control Board, Assam, www.pcbassam.org. Interested bidders are requested to go through the EOI document and submit proposal in the prescribed formats along with an Earnest Money Deposit (EMD) of Rs. 10,00,000/- (Rupees Ten Lakhs only). Earnest money can be deposited either through Demand Draft in favour of the "Member Secretary, Pollution Control Board, Assam" or through online transfer (Account Name: Pollution Control Board, Assam; Account No. 10566990077, IFSC: SBIN0000221) before 5:00 PM on 10.02.2023 at the office of Member Secretary, Pollution Control Board, Assam either in person or through Courier.

The prospective bidders shall be responsible for ensuring that their proposals along with EMD reach the office of Pollution Control Board on or before the stipulated date and time. Any proposal received after the prescribed date and time shall be rejected outright by Pollution Control Board, Assam.
