Caution Notice to the Industrial Units including Manufacturing & Service Sector located within 1 Km radius on both side of the Highway from Airport to Khanapara Junction and around 2 Km radius of Indira Gandhi Athletic Stadium, Sarusajai, Guwahati

In greater public interest and in view of maintaining Air Quality during the FIFA U-17 World Cup, 2017 to be held in Guwahati, the Pollution Control Board, Assam hereby directs all the industrial units located within 1 Km radius on both side of the Highway from Airport to Khanapara Junction and around 2 Km radius of Indira Gandhi Athletic Stadium, Sarusajai, Guwahati to operate their units with utmost care so that in no any way can cause air pollution in the surrounding area as mentioned during FIFA U-17 World Cup, 2017 matches to be held from 08th October, 2017 to 21st October, 2017.

This order is issued in exercise of power vested under Section 33(A) of the Water (Prevention & Control of Pollution) Act, 1974 and 31(A) of the Air (Prevention & Control of Pollution) Act, 1981 as amended. Failing to comply with the Board directives will be liable to face legal actions under prevailing Acts & Rules in force.

This order supersedes the earlier Notice issued vide No. WB/G-1249/15-16/51 dtd. 04-10-2017 and published in the 'Assam Tribune' on 05-10-2017.
