As per recommendation of the Department of Industrial Policy and Promotion (DIPP) communicated through 'EoDB-Business Reform Action Plan 2017, wherein it is mandated online submission of Inspection Report within 24 hours to the Department.

The Board vide reference (ii) also issued instructions for scheduling compliance inspections based on industry categorization. Board vide reference (iii) has already issued instruction with regard to implementation of new categorization of industries as notified and directed by CPCB vide No. B-29012/ESS(CPA)/2015/16 dtd. 07.03.2016.

Also, Govt. Assam vide Notification No. MI.40/2015/Pt-IX/95 dtd. 19/06/2017 constituted a 'Central Inspection Agency' (comprising member of 14 Govt. departments including PCBA) for the purpose of overall supervision and administration of Centralized Compliance Inspections, wherein under Operational Framework (sl. no. 5), it is mentioned that after the inspection, the final report to be uploaded within 24 hours to the concerned department through single window clearance system.

In continuation to the above, for the compliance inspections under the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981, Pollution Control Board, Assam amended the Notification No. WB/G-1248/15-16/11<sub>/3016</sub> dtd. 15<sup>TH</sup> Mar, 2016 as -

The officers of Pollution Control Board, Assam are directed to submit/upload the inspection report of the industry/unit within 24 hours to the department in working days and in normal condition.

It will come into force with immediate effect.
