Sub: SHOW CAUSE NOTICE.

Ref: i) WP(C) No. 375/2012 (Paryavaran Suraksha Samiti & Anr. Vs The Union of India & Ors.) before the Hon'ble Supreme Court of India.

ii) Board's Notification vide No. WB/G-1283/16-17/245 published in The Assam Tribune on 12.04.2017.

WHEREAS, the Hon'ble Supreme Court of India had passed an order on 22.02.2017 in WP(C) No. 375/2012 (Paryavaran Suraksha Samiti & Anr. Vs The Union of India & Ors.) wherein it is directed that industries which do not have fully operational primary Effluent Treatment Plant should be restrained from any further industrial activity.

WHEREAS, in compliance of the aforementioned order of Hon'ble Supreme Court of India, Pollution Control Board, Assam published a Notification vide No. WB/G-1283/16-17/245 in the "The Assam Tribune" on 12.04.2017 directing the industrial units discharging effluents to install primary Effluent Treatment Plant to make the same fully operational by 22.05.2017.

WHEREAS, the concerned Regional Office in compliance of the Hon'ble Supreme Court's order has carried out an inventorization of industries which are operating without functional primary Effluent Treatment Plant and accordingly informed that your industrial unit has been operating without primary Effluent Treatment Plant thereby you have violated the Board's Directions as well as aforementioned order of the Hon'ble Supreme Court of India.

NOW THEREFORE, under the above facts & circumstances, Pollution Control Board, Assam is constrained to inform you that you have non chalantly violated the provisions of law in force causing pollution to the Environment and in exercising powers conferred upon it under Section 33(A) of the Water (Prevention & Control of Pollution) Act, 1974 as amended till date you are directed to file objection if any within 15 (fifteen) days from the date of issue of this letter against proposed direction of Closure of your unit which will include disconnection of electricity & other essential services to your unit.
