Sub: SHOW CAUSE NOTICE.

WHEREAS, under Section 17 of the Water (Prevention & Control of Pollution) Act, 1974 one of the function of the State Pollution Control Boards (SPCB) is to plan a comprehensive programme for the prevention, control or abatement of pollution of streams, river, various water bodies and to secure the execution thereof;

AND WHEREAS, the Hon'ble Supreme Court of India had passed an order on 22.02.2017 in WP(C) No. 375/2012 (Paryavaran Suraksha Samiti & Anr. Vs The Union of India & Ors.) wherein it is directed that industries which do not have fully operational primary Effluent Treatment Plant should be restrained from any further industrial activity.

AND WHEREAS, in compliance of the aforementioned order of Hon'ble Supreme Court of India, Pollution Control Board, Assam published a Notification vide No. WB/G-1283/16-17/245 in a local daily newspaper namely "The Assam Tribune" on 12.04.2017 directing the industrial units discharging effluents to install primary Effluent Treatment Plant to make the same fully operational by 22.05.2017.

AND WHEREAS, following the above the Regional Office, Guwahati of the Board vide their letter No. APCB/ROG/T-3037/08-09/PT-II/54 dtd.26.04.2017 has also issued necessary instructions to you regarding requirement of functional primary ETP in your unit premise for discharging effluent within prescribed norms;

AND WHEREAS, the concerned Regional Office in compliance of the Hon'ble Supreme Court's order has carried out an inventorization of industries which are operating without functional primary Effluent Treatment Plant and accordingly informed that your industrial unit has been operating without primary Effluent Treatment Plant thereby you have violated the Board's directions as well as aforementioned order of the Hon'ble Supreme Court of India.

NOW THEREFORE, under the above facts & circumstances, Pollution Control Board, Assam is constrained to inform you that you have nonchalantly violated the provisions of law in force causing pollution to the Environment and in exercising powers conferred upon it under Section 33(A) of the Water (Prevention & Control of Pollution) Act, 1974 as amended till date you are directed to "SHOW CAUSE" within 15 (fifteen) days from the date of issue of this letter why necessary stricter action will not be initiated against you.

Failure to comply with the direction above within the specified time frame of 15 (fifteen) days from hereof may attract immediate Closure of the industry along with disconnection of electricity and other essential services.
